Schedule and length requirements

Please note that due to schedule constraints, **contributors are required, if at all possible, to deliver their papers in electronic form.** The deadline for receipt of your final paper and the accompanying form (see below) is **Tuesday, April 4, 2000. This is an absolute deadline**—late papers cannot be included in the proceedings.

The length of your final paper cannot exceed 8 pages. Please follow the provided format as closely as possible so we can achieve a consistent, professional appearance for the volume.

Preparing and submitting a revised ICML-2000 paper electronically

1. Your paper should have been formatted using the macros and templates for LaTeX, Microsoft Word, or troff that are available at <http://www-csli.stanford.edu/icml2k/format.html>. Once your paper is finalized, use your formatting software to make a single PostScript OR Adobe Acrobat PDF file for the entire paper. If you have the ability to make a PDF file directly from LaTeX or MS-WORD, we strongly encourage you to do so. Using Acrobat Distiller (be sure to select the *press* option of Distiller) to make a PDF file from your PostScript file is also possible. Whether you will submit PostScript or PDF files, make sure to **embed all fonts you use** in the file, especially any math or special symbol fonts you use. We strongly recommend that you print and proofread your paper in its electronic form prior to submission. Professional Book Center cannot be responsible for errors occurring as a result of your preparation of the paper, and your printed out version will be your master should there be any questions.
2. Use the file naming conventions required by the conference organizers: first and last name of the presenting author, followed by a different digit for each submission by that author, followed by the extension '.ps' for a PostScript file, or '.pdf' for a PDF file.
3. Transfer your file by anonymous FTP to the revision repository at <ftp://icml2k.stanford.edu/pub/icml2k/revised/>

Permission to Publish form

Please print out and sign the *Permission to Publish* form provided with these materials and FAX it to Professional Book Center (at +1 305 946 8106) in advance of the final paper deadline (April 4). For multi-author papers, a signature by one author is sufficient. Keep a copy of the form for your files. If we do not receive this completed form, your paper cannot appear in the proceedings. However, note that this is *not* a copyright transfer document—you retain all copyright in the work, and no permission from Morgan Kaufmann Publishers is needed for you to publish elsewhere at a later date.

Important: Be sure to include your paper tracking code (filename) on the Permission to Publish form!

Author indexing space on the Permission to Publish form

Please fill in this area at the bottom of the Permission to Publish form if there could be any question about the alphabetization of authors' names—for instance, *van Dyke*, *Jim*, or *Dyke*, *Jim van?* *Epstein Barr*, *Sheila*, or *Barr*, *Sheila Epstein?*
